

## **CHINA BY THE NUMBERS**

NSP made multiple appeals for guidance, but MOFCOM gave none for first time ever

First case in history self-initiated by MOFCOM rather than domestic petitioners

Chinese Ministry of Commerce launched two investigations into imports of US sorghum

Five grain traders submitted AD questionnaires

NSP submitted nine farmer CVD questionnaires

25% tariff announced on sorghum the same day NSP submitted questionnaires 25

NSP registered 29 parties in the investigations

Preliminary AD tariff announced after no meaningful review of submission 178.6

Combined, questionnaires included almost 200 pages each

From initial launch to submission, staff logged roughly 1,000 office hours

Deadline met with 2,000-page submission in Mandarin

Bushels en route to China that were redirected **60,000,000** 

500,000,000 Tariff liabilities when AD tariff announced
